## INTERNATIONAL STUDENT CONTRACT

To meet the requirements as an F-1 international student, I agree:

- 1. To pay for my tuition and fees at the time of registration.**  
*I understand that the Admissions and Records Office will drop my classes if I do not pay. I will contact the International Student Center if I need more time to receive money from my home country.*
- 2. To complete a minimum of 12 units in Fall and 12 units in Spring at Fullerton College.**  
*Withdrawing from a course and receiving a "W" does not count towards completion of units. If I want to take less than 12 units, I must get authorization from the ISC.*
- 3. To register in only one 3-unit class that is completely online.**  
*I understand that if I register in more than one online class that it will not be counted toward the 12 unit course load for satisfactory status.*
- 4. To work towards and make degree progress in accordance with the college's Academic Dismissal policy.**  
*I agree to enroll in courses required for the major listed on my I-20 and earn a minimum GPA of 2.0 or higher each semester. Failure to do so may result in dismissal from Fullerton College.*
- 5. To have health/accident insurance coverage for the duration of my studies and Optional Practical Training at Fullerton College.**  
*I understand that I am required to purchase insurance from Fullerton College every semester and at least 3 business days (Monday-Friday) before my registration appointment.*
- 6. Not to accept unauthorized employment.**  
*I understand that I am permitted to work on-campus only if I maintain my status. Off-campus employment without authorization from the International Student Center and US Customs and Immigration Service is illegal and is grounds for deportation.*
- 7. To report all changes in my personal and academic records to the International Student Center. Changes include reduction in units, change in name, address, phone number, etc.**  
*I understand that the U.S. government requires Fullerton College to report all changes in my record. In my best interest, I will contact the ISC before making any changes to my academic and personal records.*
- 8. To use my email address as the major form of communication with the Fullerton College International Student Center.**  
*I will provide the ISC with my most current email address and will check it at least once a week to stay informed of important F-1 visa news and regulations that may affect my status. I understand that Fullerton College provides FREE email addresses to all students and that I have access to email at the many computer labs on campus.*

**I understand that failure to meet any of the above agreements may result in termination of my I-20 and immigration status at Fullerton College. Signatures must be handwritten with pen or signed with the paid Adobe version that includes a timestamp.**
