## INTERNATIONAL ADMISSION: STATEMENT OF FINANCIAL SUPPORT

You are required to certify that you will have a minimum of USD **\$21,967** for expenses incurred during your first academic year at Fullerton College, exclusive of travel costs. You are also required to certify that you will pay for these expenses in future years of study should the length of your academic program require more than one year. You should anticipate tuition increases in subsequent years. Students who are self-sponsoring must complete the certification of self-sponsorship and are required to show funds for the duration of two (2) academic years.

While computing your expenses, you should bear in mind that on-campus employment is limited and F1 visa students cannot work off campus without authorization from the college and the US Citizenship and Immigration Services. Work authorization is not granted until after the student has been in the United States for 1 academic year and meets specific application criteria. Therefore, you should not look for income from employment, either part time or full time, to supplement your finances during the academic year. Dependents of F1 students are not permitted to work under any circumstances.
